IN RE: BRIAN R. COOK BBO # 547090 NO. BD-2019-083 and BD-2019-101 Judgment (Accepting Affidavit of Resignation As A Disciplinary Sanction) entered by Justice Wendlandt on January 13, 2022.¹

The respondent's Affidavit of Resignation was accepted as a disciplinary sanction.

SUMMARY²

The respondent submitted an Affidavit of Resignation to the Board of Bar Overseers, see S.J.C. Rule 4:01, § 15, in which he admitted to a range of misconduct set out in four counts of a Petition for Discipline: one count comprising several criminal convictions, in violation of Mass. R. Prof. C. 8.4(b) (criminal act that reflects adversely on honesty, trustworthiness, or fitness), 8.4(d) (conduct that is prejudicial to the administration of justice), and 8.4(h) (conduct that reflects adversely on fitness to practice); two counts of misconduct in the context of representing two clients, in violation of Rules 1.5 (prohibiting agreement for or collection of illegal or clearly excessive fee), 1.4(a)(3) (keep client reasonably informed), 1.4(b) (explain a matter to the extent reasonably necessary for client to make informed decision), 1.6(a) (do not reveal confidential information relating to the representation), 8.4(a) (do not attempt to violate Rules or knowingly assist or induce another to do so), 8.4(c) (conduct involving dishonesty, fraud, deceit, or misrepresentation), 8.4(d), 8.4(h), 1.15(b) (trust property to be held in trust account, separately from lawyer's own property) and 1.15(c) (promptly notify and deliver funds to client); and, in a fourth count, knowingly failing to comply with an Order of Immediate Administrative Suspension, in violation of Rule 3.4(c) (do not knowingly disobey obligation under the rules of a tribunal) and S.J.C. Rule 4:01, § 17(b).

By vote dated December 13, 2021, the Board of Bar Overseers recommended to the S.J.C. that it accept the respondent's Affidavit of Resignation as a disciplinary sanction.

On January 13, 2022, Justice Wendlandt accepted the respondent's Affidavit of Resignation as a disciplinary sanction.
